NOTICE OF PUBLIC STATEMENT HEARINGS

(Issued May 23, 2016)

The New York State Public Service Commission (Commission) seeks public comment on a proposal by Consolidated Edison Company of New York, Inc. (Con Edison or Company) to increase electric and gas rates for customers.

On January 29, 2016, Con Edison filed a request with the Commission for approval of a major change in the amount of revenues it collects from customers through the rates they pay for electric and gas delivery service. Con Edison proposes to increase its electric delivery revenues by approximately \$482 million (a 9.5% increase) for the 12-month period beginning January 1, 2017. The Company also proposes to increase its gas delivery revenues over the same period by approximately \$154 million (an 8.2% increase). Included in the Company's proposals is funding for the implementation of Advanced Metering Infrastructure (AMI) in homes and businesses and funding for gas infrastructure improvements including an initiative to accelerate Con Edison's gas main replacement program.

Under New York State Law, the Commission must consider a utility's proposal and may adopt or reject it in whole or in part, or adopt changes not proposed by the Company. Administrative Law Judges are presiding over the gathering of public comments and all evidence relating to the proposal. As

indicated in this Notice, two public statement hearings will be held to obtain comments from the public concerning Con Edison's proposals.

Each public statement hearing will be preceded by a short description by the Department of Public Service Staff to explain the rate case process generally and how individuals can participate. At the public statement hearing itself, members of the public will have the opportunity to present comments on Con Edison's proposals.

It is not necessary to be present at the start of the hearing, to make an appointment in advance, or to present written material in order to speak at the hearing. Persons will be called to speak after completing a participation card. The hearings will remain open for at least an hour and will continue until everyone wishing to speak has been heard or other reasonable arrangements have been made. A verbatim transcript

of the hearings will be made for inclusion in the record of these proceedings.

Via the Internet¹ or Mail: Comments may be entered directly into the case file by locating the case via the home page of the Commission's website, www.dps.ny.gov, by clicking on "Search" and entering 16-E-0060 or 16-G-0061 in the "Search by Case Number" field. In the opening page under either case number, a commenter should click on the "Post Comments" button located at the top of the page and leave the comment by completing the form to which he or she is then directed.

¹ Some individuals, who would find it advantageous to provide comments via the internet, may have only limited access to internet service. However, many libraries offer free internet service which could be used to assist these persons.

Toll-Free Opinion Line: Individuals may choose to submit comments by calling the Commission's Opinion Line at 1-800-335-2120. This line is set up to receive in-state calls 24-hours a day. These calls are not transcribed but a summary is provided to the administrative law judges who will report to the Commission.

Comments will become part of the record considered by the Commission. Written comments may be read on the website by searching Case 16-E-0060 or 16-G-0061 and clicking on the "Public Comments" tab.
